

Terms and Conditions of Hang Seng Credit Card x Weekend Weekly Dining Awards 2026 - \$1 Foodie Upgrade +FUN Everyday Dining Offers (the “Promotion”):

General Terms and Conditions:

1. Unless otherwise specified, the promotion period is valid from 15 June 2026 to 16 August 2026 (both dates inclusive) (the “Promotion Period”).
2. The Promotion is applicable to Hang Seng Credit Card, Affinity Card and enjoy Spending Card (“Eligible Credit Card”), but excluding Commercial Card, Business Card, other Spending Card, Renminbi Credit Card, USD Visa Gold Card, e-shopping Mastercard and Private Label Cards.
3. Unless otherwise specified, the offers are applicable to physical outlets in Hong Kong only. Offers are not applicable to online shops or mobile app purchases.
4. Unless otherwise specified, the offers are not transferable, and cannot be redeemed or exchanged for cash, other products or discounts, and cannot be used in conjunction with other promotional offers, discounts, coupons, cash coupons, cake coupons or membership benefits/ VIP cards/ VIP bonus point programs of the Merchant.
5. Offers are available on a first-come-first-served basis, while stocks last. Offers are subject to availability, and the offer details may be changed from time to time without prior notice.

7. All products, services and information related to this Promotion are directly sold and supplied to customers by participating merchant(s) (the “Merchant(s)”) who are solely responsible for all related obligations and liabilities. The Merchant(s) assumes full responsibility and obligation for (i) the quality of goods, products, and services provided, and (ii) the information, product content, and other descriptions provided for this promotion. Hang Seng Bank Limited (the “Hang Seng”) and Weekend Weekly shall not bear any responsibility or liability in this regard.
8. The Merchant(s) may impose additional terms and conditions on the Offers, please check with the respective Merchant(s) for details.
9. The Offer of the Merchant(s) shall terminate immediately upon closure of the relevant Merchant(s).
10. Customers understand and accept that Hang Seng and Weekend Weekly are not the supplier of the products and/ or services supplied by the Merchant(s). Hang Seng and Weekend Weekly shall bear no liability relating to any aspect of the products

and/or services, including without limitation, their quality, the supply, the descriptions of products and/or services provided by the Merchant(s), any false trade description, misrepresentation, mis-statement, omission, unauthorized representation, unfair trade practices or conduct in connection with the promotion of the rewards or the products and/or services under the Promotion, by the Merchant(s), their respective employees, officers and/or agents.

11. The Promotion is governed by these Terms and Conditions and other terms and conditions stipulated by the Merchant(s). In case of any inconsistency between other terms and conditions and these Terms and Conditions, these Terms and Conditions shall prevail.
12. Hang Seng and the Merchant(s) reserve the right to suspend, revise or terminate the above offers and to amend the terms and conditions thereof at any time without prior notice. In case of any disputes, the decision of Hang Seng and the Merchant(s) shall be final.
13. In case of any disputes, customers are required to present the relevant original transaction document(s), sales receipt(s) and credit card sales slip(s) (if applicable) for further investigation.
14. In case of any disputes, the decision of Hang Seng and the Merchant(s) is final.
15. No person other than the customers, Hang Seng (which includes its successors and assigns) and Weekend Weekly (which includes its successors and assigns) has any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provision of these Terms and Conditions.
16. These Terms and Conditions are governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region.
17. These Terms and Conditions are subject to prevailing regulatory requirements.
18. The English version of these terms and conditions prevails whenever there is any discrepancy between the English and Chinese versions.

Additional Terms and Conditions for the Offer:

1. During the Promotion Period, customers who settle a single net transaction of HKD50 / HKD150 / HKD300 or above with the same Eligible Credit Card at physical outlet of the Merchants (the “Eligible Transaction”) may purchase 1 “Foodie Lucky Draw Card” physical card pack with HKD1 (the “Offer”).
2. Each “Foodie Lucky Draw Card” card pack contains 1 “Foodie Lucky Draw Card” randomly assigned by the Merchant. The “Foodie Lucky Draw Card” entitles the customer to redeem 1 designated food/drink.
3. The customer must open the “Foodie Lucky Draw Card” card pack in the presence of the Merchant’s staff. Redemption of the designated food/drink must be made immediately when the “Foodie Lucky Draw Card” card pack is opened.
4. Each Merchant offers 3 designated food/drink under the Offer. The food/drink to be redeemed is determined by the “Foodie Lucky Draw Card” and is not selectable by the customer.
5. Payment must be fully settled by the Eligible Credit Card and the HKD1 redemption amount must be settled together with the Eligible Transaction in the same single transaction. Split bill will not be accepted.
6. Unless specified, the Offer cannot be used in conjunction with any other promotion, discount offers, gift vouchers, cash coupons, associate benefits, credits and points (including Rewards Dollars).
7. Any spending amounts settled by e-wallet (including but not limited to AlipayHK, WeChat Pay HK, Tap & Go and PayMe by HSBC) are not accepted for the Offer.
8. Designated food/drink may subject to limited quota and is available on a first-come, first-served basis. No prior notice will be given if quota lasts. Customers are advised to confirm with the merchant(s) regarding the availability of the quota before transaction.
9. If the designated food/drink is unavailable for any reason at the time of redemption (including but not limited to out-of-stock, quota full, or temporary suspension of supply), the Merchant will inform the customer and arrange for the customer to select **one** of the other remaining designated food/drink available.
10. If the “Foodie Lucky Draw Card” physical card pack cannot be provided at the time of purchase for any reason (including but not limited to out of stock, insufficient supply, delivery delay, or other unforeseen circumstances), the merchant will provide an electronic “Foodie Lucky Draw Card” card pack in place of the physical

card pack. The electronic “Foodie Lucky Draw Card” card pack will be displayed on the merchant’s designated electronic device, and the customer will not be issued with any electronic “Foodie Lucky Draw Card” card pack for keeping. The electronic card pack shall have the same effect as the physical card pack.

11. Unless otherwise specified, the Offer is applicable to dine-in consumption at the Merchant’s physical outlets in Hong Kong only, and is not applicable to takeaway, delivery, online orders or mobile app purchases.
12. Each customer may enjoy the Offer once per Eligible Transaction only.
13. If the customer could not settle the transaction with Eligible Credit Card, the Offer will not apply and the customer must pay the Merchant’s original price for the redeemed food/drink.

- Hang Seng Spending Card account is a non-interest bearing account. Funds maintained in the Hang Seng Spending Card account are not protected deposit and are not protected by the Deposit Protection Scheme in Hong Kong.
