1. 您提供的與計劃相關的個人資料，限於不在適用法律禁止之列，將由恒生銀行有限公司(「我們」)作為本計劃的主事中介人用於以下一項或多項用途：
 - 給您提供產品與服務，包括促使申請、指示或請求的處理
 - 在您同意下，將強積金產品及／或服務直接促銷給您
 - 用作提升我們的產品、服務與行銷
 - 協助我們或滙豐集團遵守香港境內外法律、規例包括我們的內部政策及相關要求
 - 協助我們遵守我們或滙豐集團在香港境內外需要或收到的法律或監管規定或要求。某些情況下我們必須遵守，另一些情況下則選擇自願遵守
 - 偵測、調查並防止金融犯罪
 - 管理我們的業務，包括行使我們的法律權利
 - 與上述內容相關或您已同意的其他用途

如您向我們提供他人的資料，應依照本文件所述的告知該人我們將如何收集、儲存、使用、披露及處理其資料。

2. 如您未能向我們提供您的資料，我們可能無法提供您所要求的產品或服務。
3. 我們所持有的個人資料將予以保密，但限於不在適用法律禁止的範圍內，我們或我們的服務提供者可依第1節所述用途，提供給以下任何相關一方：
 - 其他滙豐集團公司
 - 協助我們為您提供服務或代表我們的第三方
 - 您同意我們共用您資料的第三方
 - 任何執法機關、產業組織、監管者或監管機構

我們可能會在本地或海外共用您的資料。

4. 您可以控制您從我們那裡獲得的行銷內容及方式。您可以隨時在積金易平台上更改與計劃相關的促銷偏好的設定。直銷是指在適用法律允許的範圍內，利用您的資料向您傳送由我們或滙豐集團提供的強積金產品及／或強積金服務或優惠的詳細資訊。我們可能會使用的資料如您的人口統計資料、您感興趣的產品與服務、交易行為、其他產品與服務組合資訊、財務背景、位置資料、社群媒體資料、分析資料以及由第三方提供的資訊來行銷給您。

**Personal Information Collection Statement of
Hang Seng Bank Limited as
MPF Principal Intermediary of the Hang Seng Mandatory Provident Fund
– SuperTrust Plus (the “Scheme”)**

1. Personal data provided by you relating to the Scheme will be used, to the extent not prohibited by applicable law, by Hang Seng Bank Limited (“we”, “our” or “us”) as the Principal Intermediary of the Scheme for one or more of these purposes:
- to provide products and services to you, including facilitate the processing of application(s), instruction(s) or requests
 - to send you direct marketing relating to MPF products and/or services if you’ve consented to it
 - to improve our products, services and marketing
 - to help us or the HSBC Group comply with laws, regulations and requirements, including our internal policies, in or outside Hong Kong
 - to help us comply with requirement or requests that we or the HSBC Group have or receive such as legal or regulatory ones in or outside Hong Kong. Sometimes we may have to comply and other times we may choose to voluntarily comply
 - to detect, investigate and prevent financial crimes
 - manage our business, including exercising our legal rights
 - other uses relating to the above or to which you have consented

If you provide data to us about another person, you should tell that person how we will collect, store, use, share and handle their data as explained in this document.

2. If you don’t provide your information to us then we may be unable to provide the products or services you request.
3. Personal data held by us will be kept confidential but to the extent not prohibited by applicable law, such information may be provided by us or any of our service providers to the following parties for the purposes set out in paragraph 1:
- other HSBC group companies
 - third parties who help us to provide services to you or who act for us
 - third parties who you consent to us sharing your data with
 - any law enforcement agencies, industry bodies, regulators or authorities

We may share your data locally or overseas.

4. You control what marketing you receive from us and how you receive it. You can change this at any time by changing your marketing preferences relating the Scheme on the eMPF Platform. Direct marketing is when, to the extent permitted by applicable law, we use your data to send you details about MPF products and/or MPF services or offers provided by us or the HSBC Group. We may use data such as your demographics, the products and services that you’re interested in, transaction behaviour, other products and services portfolio information, financial background, location data, social media data, analytics and information from third parties when we market to you.
